## Declaration of the establishment of the institution of the Scotland Office in co-operation with the Foreign Office of the Empire of Austenasia

This document describes and sets out the plans with regard to the conception and operations of the 'Scotland Office' - an official centre of official communication and diplomatic affairs run from a joint office in Edinburgh, Scotland between the Landashir'n Government and the Foreign Office of the Empire of Austenasia.

As such, officials from the Austenasian Foreign Office as well as all Landashir'n Government Administrators are to be invested in this scheme, headed by James von Puchow in his capacity as Administrator for Government Representation in Landashir and as Deputy Chief Ambassador in Austenasia.

Officially, this collaboration is to be hosted by the Landashir'n Government, but not under its direct control. For this reason, whilst this declaration merely establishes the office, the future work between the two aforementioned parties is indicative of the arrangement to follow this joint effort.

The Scotland Office refers to a forum of several different roles and responsibilities shared between the two aforementioned states. **The Office is not its address**, but the address, which shall not be disclosed in this document, is necessary as a means to receive and send written correspondence.

It is also hoped that by both Landashir and Austenasia sharing a hub in Scotland, it will be possible to host audiences with other statespeople as well as organise conferences in the future in the Scottish capital.

To this end, the Landashir'n Government proposes the following as establishing the Scotland Office and awaits the response of the Government of Austenasia which is currently in talks with us:

- The Scotland Office is an official department of both the Community of Landashir and the Empire of Austenasia.
  - o The Scotland Office is registered at an undisclosed residential address in Edinburgh, Scotland
    - This address does not form part of either nations' territorial claims. It remains under the jurisdiction of Scottish law and is legally British territory
  - o The Scotland Office is hosted by James von Puchow on behalf of the Landashir'n Government and the Foreign Office of the Empire of Austenasia
- The Scotland Office is multifaceted and hosts the following:
  - o a Government Office and contact address for the Landashir'n Government in Great Britain
  - o the Office of the Deputy Chief Ambassador of the Empire of Austenasia
  - o an Consular Office of the Foreign Office of the Empire of Austenasia for Scotland
  - o an open forum for micronationalism and secessionist movements within Scotland and the rest of the northern British Isles
- The Scotland Office would benefit greatly by having an online space such as a website to inform people of all its activities
- It would be advantageous to expand on the proposed activities of the Scotland Office at a later date following talks between the Landashir'n Government and the Government of the Empire of Austenasia
